2AD Memorial The balance in the Memorial Trust Fund as of Dec. 10, 1954, at the market value of securities owned by the Trust, was 26,103 pounds. 5 shillings, 11 pence. The Trustees have been working diligently toward carrying out the terms of the Declaration of Trust. However. the City Council of Norwich are presently of the opinion that the Library Building to be erected will not be on anything approaching as grand a scale as the Americans who originated the idea of the Memorial Trust apparently expected. The City Architect could not reconcile the idea of a Memorial with a busy entrance Hall and the usual more sedate and quiet location normally associated with a Memorial for the fallen soldiers. The City Council of Norwich are of the opinion that if the Memorial, as originally contemplated by the Americans, were to be built, it would cost the taxpayers of Norwich approximately 25,000 pounds from their own pockets to construct the entire Library Building on a scale appropriate for the proposed 2AD Memorial. The present status is this: (1) The Counsellor for the Board of Governors is of the opinion that legally the Trustees cannot apply income from the Trust for scholarships until and unless the City Council have definitely and finally decided either not to construct a new Library Building or to construct such a building that it would not be feasible to have the 2AD Memorial in the building; (2) The Board of Governors and the City Council believe that there are excellent prospects of the construction of a library building being undertaken within the next eighteen months - the building to be considerably smaller than was anticipated in 1945, but still being large enough for dignified and fitting Memorial rooms to be reserved for the Americans. Thus, the present status is that we are forced necessarily to wait at least another year, and possibly longer, for any final decision about the Library Building. The above situation was reviewed but no further action was taken at the business meeting. General Milton Arnold attended the September Board meeting in September, but no change is reported. Incidentally, the site selected is adjacent to the fire station in Norwich. No one could remember exactly where that was (they should have told us the name of the nearest pub).
