There were stories in three papers about the meeting and the Mayor of Wilmington, Delaware proclaimed November 10, the day of the meeting as "2nd Air Division Association, Eighth Air Force Day" in Wilmington. The Wing has undertaken a project under the direct supervision of General Ligon, who was the speaker at the November meeting. A questionnaire has been developed and is being distributed to non-reenlistees in the Air Force. The object of the questionnaire is to find out why men do not reenlist and what the Air Force could do to stimulate reenlistments.

- 2 -Military Affairs Committee Dick Clough, our 1956 Chairman of Military Affairs, wrote to General Lauris Norstad in November, congratulating him on his assumption of command of the NATO forces in Europe. He also wrote to Charles E. Wilson, Secretary of Defense, commending him for his decision to spell out clearly the roles of the Army and Air Force in relation to guided missiles. In a letter to President Eisenhower, Dick put the Association on record as being in favor of his actions in the Mid-East and Hungarian crises.
