I didn't realize just how much was involved in planning the trip to Norwich, England, and my estimate of February was slightly off, I would say. Plans are coming along just fine but I do need your assistance before final plans can be made. I would like to make it as convenient as possible for all concerned so that it will be more enjoyable. Consequently, I need all the information on the inclosed questionnaire.

The chartering of an aircraft is governed by the regulations of the International Air Transport Association and the Civil Aeronautics Board of the United States.

That portion of the Rules and Regulations which applies to you is as follows:

All passengers traveling on the charter must have been members at the time of application for the charter and must have been such a member for at least six months prior to departure date.

Only bonafide members and their dependent immediate families, living in the same household, are eligible to travel.

As a word to the wise, let me quote a part of the charter application. "If it is discovered that any of the individuals of such members (i.e., parents living in the same household as such members, spouses or dependent children) or if any of the answers to the questions set out herein are false, or should the carrier become aware of any conditions which are inconsistent with the rules and regulations of proper aeronautical authorities respecting the formation of charter groups to which the carrier must conform, the charter is subject to cancellation and without liability to the carrier." This cancellation can take place either before or during the flight. I bring this to your attention so that you will not innocently jeopardize the charter flight.

There is no limit as to the number of immediate dependents that you may take.

There will be no reduction in the rate for children.

The income tax deduction will apply only to the member making the $\ensuremath{\operatorname{trip}}_{\bullet}$

1962 NORWICH REUNION (Cont'd)

A Registration Fee of \$15 per person, which is not returnable, must accompany the application to cover expenditures involved in setting up the charter.

The flight will leave on or about the 15th of October 1962 and returning on a date to be determined after compilation of the inclosed questionnaire. Also the place of departure will be determined from the same source.

A tentative charter application has been made with Pan American World Airways for a DC-7C which has approximately 87 seats. A final confirmation can not be made until I have received your applications. Reservations will be made on a first come basis. However, if there are enough reservations to warrant the chartering of another aircraft, we can do so.

I know this is the part you have been waiting for. How much will it cost me? This again must be determined from the inclosed questionnaire. maximum cost will be \$325 and the minimum cost will be \$225, per person, round trip. This variation in price covers the most (i.e., Departing Chicago in September or October and returning from Paris to Chicago in October) and the least (i.e., Departing New York in September or October and returning from Paris to New York in October). The cost will be less if we return in November. You might bear this in mind while you are making your preferences.

Your application must also be accompanied with a \$50.00 deposit in addition to the Registration Fee. The exact fare will be determined after I have compiled the questionnaires. Any monies not used will be returned to you after the termination of the flight.

The balance of the fare must be paid mot later than 1 July 1962, in three equal installments. Those desiring to make monthly installments may do so. If you are forced to make a cancellation, this must be done before 1 July 1962 and your money will be returned to you. We cannot make any cancellations after this date, unless someone is waiting to pick up a cancellation.

One of our members is planning a trip over to England during the late summer this year and will bring back a report to the membership at the October meeting which will be held in Pittsburgh. We are hoping that it will be Percy Young since he is our Advisor on the Memorial Trust Fund and is up-to-date on the progress of this Memorial. We will have a better idea of just what activities are being planned for this formal dedication.

My next door neighbor here at Keesler who was born in England but is now a naturalized citizen was kind enough to have one of her relatives bring me a AA Book when coming to the States for a visit recently. It lists the hotels in England with the exception of London. I'll give you the information that it lists for the hotels in Norwichs

*** Castle, 90 rooms; HC: private bath 13, central heating; Lift; Night Porter(s) on Duty; TV available; BB (Bed & Breakfast) charges 27/6 (27 shillings and sixpence) to 35/.
*** Maid's Head, 64 rooms HC: pb 5, NP, BB. 27/6 to

30/. ** Bell, 41 rooms: HC; (A)(Annex) 13 rooms: HC: NP: BB 22/6.

*** Royal, 95 rooms: HC: pb 10: Lift: NP: TV: BB 30/ to 32/6.

Don't these hotel names sound familiar? The above listing is to give you some idea of what the price of rooms will be. The shilling is now worth about 14¢ in American money.

I guess that about covers all the information about the Norwich trip that I have right at the present moment. So, if you are planning on making this trip with us, please send in the questionnaire right away so that the applications can be printed and returned to you as soon as possible.
