MINUTES OF 20th ANNUAL MEETING 24 June 1967 Sheraton-Park Hotel, Washington, D.C.

The meeting was called to order by President Charles T. Merrill at 10:30 A.M.

Minutes of last years meeting were read and approved.

Treasurer report. In the absence of the Treasurer, Ray Hess, it was decided to ask him to make a report as of 30 June 1967 and to publish the report in the next Newsletter.

Hathy Veynar reported on her activities as Publicity Vice-President, particularly efforts to get new and reactivate old members.

Evelyn Cohen reported that we have about 600 dues paying members.

President Merrill commented on goals of the Association.
(1) fellowship (2) improve communications through the newsletter and (3) need for items to publish in the newsletter.

Jordan Uttal reported on progress of the plan for flight to Norwich in 1968. Discussed alternatives of charter flights (1) by scheduled airlines, (2) non-scheduled airlines (3) group flights (25 or 50) on regular flights. Moved and passed that Jordan try to arrange one or more groups flight in 1968. A statement will be prepared by Jordan for inclusion in the next newsletter.

A motion was passed thanking Hathy and Milton Veynar for work done in preparation for this 20th Annual Meeting.

Nominating Committee reported as follows:

President - John Jacobowitz Vice President - Robert (Bud) Pellican Publicity Vice President - Hathy Veynar Membership Vice President - Evelyn Cohen Secretary - Ray Strong Treasurer - Ray Hess

Secretary was instructed to cast a unanimous vote.

It was decided to have the 1968 reunion in Chicago unless we have group flights to Norwich - in which case the 1968 meeting will be in Norwich and the 1969 meeting in Chicago. Tates of June 21, 22 & 23, 1968 set if meeting is in Chicago.

Motion passed directing the treasurer to send Hathy and Evelyn \$100 each for outstanding work during the year.

Discussed gifts and memorials to the library. Hathy to publish in the newsletter the provisions for making gifts to the library. Concerning the gifts in memory of Percy Young. It was decided to ask "th friends of Percy Young" to give small donations (\$2 or \$3) to purchase the "Encyclopedia of Philosophy" for \$219. No money to come out of treasury and any over \$219 to go to the library. This Encyclopedia is one needed by the library. Motion was made by Joe Whitaker and passed.

Evelyn Cohen made a notion that we send \$100 from the Treasury to the Library in Morwich to purchase books of their choice. Passed.

Motion by Jordan Uttal that all members attending be declared official delegates. Passed.

Motion by Dr. Jacobowitz as follows:

"That our President, Charles Merrill write, at once, to the Ecard of Governors of the Memorial Trust of the 2nd Air Division, USAF, - c/o The Clerk, Mr. F.R.D. Walters requesting that there be added to the Board of Governors, a member of the 2nd Air Division Association appointed by the Executive Committee of the 2nd Air Division Association every three years - and that the Chairmanship of the Library Book Cormittee, held by the late Percy Young be passed to this appointed individual."

It was announced by President Chuck Merrill that, if the Board of Governors of the Memorial Trust agree to the above motion, the Executive Committee would appoint Jordan Uttal as our representative to the Board of Governors and Chairman of the Library Book Committee for the next three years.

Motion by Jordan Uttal thank Chuck Merrill for his good work and thanking Hathy and Evelyn and Jackie Hanify for their good work and years of support.

Meeting adjourned at 11:50 A.M.
